

Gifts in Wills and Other Estate Plans

They ensured safe and equitable access to the outdoors and found within themselves the seeds of a lifetime commitment to conservation and the environment.

Simple Ways to Support a Sustainable Future:

- Include a gift in your will or living trust.
- Name the SCA as a beneficiary of your retirement account, life insurance or other financial account.
- Include the SCA in your succession plan for your donor-advised fund.

A Gift in Your Will or Living Trust

There are several ways to include a gift to the SCA in your will or living trust. Some options:

- You can leave a defined sum of money.
- You can leave a percentage of funds left over after other gifts and debts are paid and your loved ones are provided for.
- You can leave some percentage of your estate.
- You can make a secondary or contingent gift that comes to SCA only if your other beneficiaries do not survive you or other specific gifts cannot be fulfilled.

If you would like to direct your gift to a particular project or for a particular purpose, we can assist you and your attorney in drafting language that ensures your gift will be used as you intend.

Gifts by Beneficiary Designation

You can name the SCA as a beneficiary of some percentage or all of your:

- Retirement accounts
- Life insurance plan
- Bank and brokerage accounts

You can make a meaningful difference for the SCA by simply completing a beneficiary form — there's no need to update your will.

To make a gift through a beneficiary designation, contact your retirement plan administrator, insurance company, bank, or financial institution for a change-of-beneficiary form. You may be able to request or download the form from your online account portal.

You can name the SCA as the sole beneficiary or allocate some percentage to us. You can also name the SCA as a second-in-line or contingent beneficiary.

Donor-Advised Fund Succession Planning

If you have a donor-advised fund, you can designate the SCA to receive all or some of the funds remaining at the end of your life as part of your fund succession plan, or direct that funds be granted over several years. We encourage you and your financial advisors to reach out to learn more about how to make a significant investment in conservation now and in the future.

A family legacy spans SCA's history and continues today

The Bobowicks have had what they fondly call "a family affair" with the Student Conservation Association almost from the beginning.

In 1958, Morton Bobowick was 15 years old when he responded to an ad in National Geographic and landed a spot on the SCA's second crew improving trails and restoring Hume's Ranch in Olympic National Park. His daughters followed in his footsteps: Marla in 1982 and Michelle in 1985. Not to be outdone, in 1992, their mother, Susan, signed up with Morton for an adult crew at Yellowstone National Park.

That same year, their cousin Rick Barga volunteered with the SCA at Olympic National Park, an experience he says changed his life. Then in 2014, another cousin, Julian Liber, volunteered at Marsh-Billings-Rockefeller National Historic Park.

Morton Bobowick's legacy continues to be an inspiration to new generations of their family and new SCA members carrying on the Bobowick Family's conservation values.

The Liz Putnam Legacy Society

Liz Putnam founded the Student Conservation Association in 1957, launching a movement that has inspired generations of young people to serve the planet.

She envisioned a way to enlist student volunteers to plan, act, and lead while they protect and restore natural and cultural resources.

In addition to the host of honors she has received over her lifetime, Liz was presented with the Presidential Citizens Medal by President Barack Obama in 2010 for performing exemplary deeds of service for her country and fellow citizens.

Frequently Asked Questions and Considerations

Do I need a will?

Yes! Every adult needs a will (or living trust, or both!) and should review it every five years or so to ensure that it's up to date. A will and/or living trust accomplishes some important tasks, including allocating your assets, reflecting your most important relationships, designating guardians for children and caregivers for beloved companion animals, and even giving gifts to charity.

• I have a will and/or trust, but I'm not able to update it now. How can I include a gift to the SCA?

Naming us a beneficiary of your retirement plan, financial account or donor-advised fund is as simple as updating your beneficiary designation form and doesn't require an attorney.

• I have family or loved ones that I need to take care of. How can I do that and still make a gift to the SCA?

You can make us a beneficiary of a small percentage of your estate or account, or name us a secondary or contingent beneficiary so we only receive a gift if your primary beneficiary doesn't survive you.

What if I include a gift in my will or other plan but change my mind?

None of us know what the future holds. And we understand that, sometimes, a gift that has been previously pledged to us must be allocated to more pressing needs. But the decision is always yours to make. You are never obligated by a giving decision you make today.

We encourage you to consult your professional tax or legal advisor prior to establishing a legacy gift, and to discuss your plans with your family or other trusted advisors.

An SCA alumnus builds a conservation career and mentors the next generation of SCA leaders.
