

### SCA Crew Travel Support

### Instructions for the Travel Support Form



- Participants on SCA National Crews are responsible for the cost of travel between their home and the crew location at the start and end of the crew. SCA is able to provide travel vouchers to eligible participants travelling between Southwest Airlines airports.
- Travel support is need-based, and is calculated using financial information provided by the parent/guardian of the candidate.
- This form is to request a travel voucher to cover the cost of travel to and from the crew location.
- For eligible candidates travelling between Southwest Airlines airports, travel support will cover the full cost of a flight from the participant's home airport to the crew location and back.
- Travel support recipients will receive information on how to book travel. Recipients should NOT book travel prior to receiving booking instructions from SCA.

### Frequently Asked Questions – Travel Support

## When will I find out if I'm receiving travel support?

You should expect to hear back about travel support within two weeks of sending in your completed travel support application.

## How will I get my travel support if it is awarded to me?

When you receive confirmation that you are receiving travel support, it will include instructions on how to arrange your travel details.

## Should I book my own travel while I'm waiting to hear about travel support?

No. Do not book your own travel if you are applying for travel support. If you receive travel support, you will receive specific instructions on how to book your travel.

#### Is travel support only available for flights?

Yes. Travel support will only be available for participants who are flying between Southwest Airlines airports to their crew location.

## How do you determine who is eligible for travel support?

SCA uses household financial information to determine eligibility for travel support. See the chart on this page, based on the 2018 Federal Poverty Guidelines, for details.

# What if our household income is above the amount listed on the chart, but we still need travel support in order to participate?

If your household income makes you ineligible for travel support, but you would still like to be considered, use the area above to provide additional information to support your request.
